CHARTER FOR CHILDREN'S PLAY

Children play best:

- When adults are watchful, but not intrusive, when safe ground lends courage to their discoveries.
- When their trust in life is whole, when they welcome the unknown, and are fearless.
- When their games are free from adult agendas and when their transformations require no end product.
- When their senses are directly engaged with nature and the elements.
- When they are free to become gatherers, makers and word creators in their own time and in their own ways.
- When they can play with others and make their own relationships.
- When they can play alone, be solitary and private.
- When they can become new selves through their play with others and in their own imaginings.
- When they reveal themselves, their joys, sufferings and concerns without fear of ridicule, and mystery and imagination are not denied by fact.
