ENVIRONMENTAL STATEMENT

Kineton Playgroup Ltd recognises its responsibilities to minimise the impact its operations have on the environment and seeks to achieve this through a programme of continual improvement.

Kineton Playgroup Ltd endeavours to carry out all work procedures in accordance with all relevant environmental legislation and best practice and to ensure that all employees are aware of their responsibilities to reduce their impact on the environment.

Kineton Playgroup Ltd hereby adopts this environmental policy to conserve valuable resources, improve waste minimisation, encourage the prevention of pollution and ensure compliance with relevant legislation and regulations. It is committed to:

- Work continuously to improve the effectiveness of our environmental policy
- Reduce, re-use and recycle resources whenever possible and encourage those attending our setting to do likewise and make full use of paper, cardboard, plastic, steel and glass resources
- Communicate by email to reduce paper messages
- Promote energy efficiency – turning off computers and lights and office equipment when not in use and minimising use of fossil fuels by turning down or off equipment, including heating when and where possible
- Share transport, where practical, for travelling to meetings and encourage non-polluting methods of transportation such as cycling through payment of a mileage allowance
- Prevent pollution wherever possible
- Provide appropriate environmental training and educate employees to be environmentally responsible at work and at home
- Recycle all waste possible, including using a compost bin
- Conserve water supplies e.g. by turning off taps and using reduced flush mechanisms in all toilets
- Collect rainwater for use in gardening activities
- Include recycling and environmental education as part of Playgroup and KASC activities

Kineton Playgroup Ltd also seeks to promote wider involvement in and understanding of the environment around us by all children, staff and parents through

- Education in the Environment. Kineton Playgroup has an approved Forest School site within the school grounds where Forest School sessions take place. Members of staff undertake Forest School training. Once settled at sessions, all children have the opportunity to engage in learning at the Forest School site. Kineton Playgroup Ltd promotes the ethos of Forest School play and development.
- Gardening. Kineton Playgroup Ltd plants and harvests from its own raised beds.

- Membership of organisations promoting understanding and awareness of our environment e.g., The Woodland Trust and RSPB. These links provide valuable ideas and resources for promoting good practice and environmental awareness.
